

MOST HONORED COMPANIES

2016 ALL-EUROPE EXECUTIVE TEAM

A total of 1,280 companies in Europe received votes in this year's All-Europe Executive Team survey. Of those companies, 178 received a first-, second-, or third-place ranking in one or more of the following categories: Best CEO, CFO, IR Professional and IR Program. One hundred and six companies were distinguished as "Most Honored" for receiving two or more top-three appearances. Rank is determined by weighted score wherein each first-place position is worth three points; second place, two; and third place, one.
